

### **Bíleggingartreytir**

Bíleggingar, sum verða framdar á heimasíðuni hjá Hotel Føroyar ella deildum tess, eru bindandi fyri bíleggjaran.

Møguleikar fyri at angra eina bílegging:

Bílegging av høli til veitslu, fund ella tílíkt, kann avlýsast, sum avlýsingin verður fráboðað Hotel Føroyum seinast 30 dagar áðrenn, at hølið skal nýtast. Bíleggingar avlýstar áðrenn hesa freist verða fult endurgoldnar av Hotel Føroyum. Tó veður umsitingar- og avgreiðslugjaldið ikki endurgoldið.

Bílegging av atgongd til eitt tiltak kann – um ikki annað er fráboðað í sambandi við tiltakið – avlýsast, sum avlýsingin verður fráboðað Hotel Føroyum seinast 30 dagar áðrenn, at tiltakið er sett á skrá. Bíleggingar avlýstar áðrenn hesa freist verða fult endurgoldnar av Hotel Føroyum. Tó verður umsitingar- og avgreiðslugjaldið ikki endurgoldið. Bíleggingar avlýstar eftir hesa freist verða ikki endurgoldnar uttan nærri avtalu um hetta er gjørd frammanundan ella í sambandi við avlýsingina.

Viðvíkjandi møguleikanum at angra bílegging av kamari, verður víst til reglurnar niðanfyri, sum bert galda kamarsbíleggingina og ikki aðra bílegging, t.d. til eitt tiltak, hóast bíleggingin av kamari og t.d. tiltakið fer fram í somu bílegging og gjaldi. Bíleggingar avlýstar eftir hesa freist verða ikki endurgoldnar uttan at nærri avtalu um hetta er gjørd frammanundan ella í sambandi við avlýsingina.

Bílegging av mati og drekkivørum kann ikki avlýsast.

Bílegging av tiltøkum, tænastrum og vørum, sum eru til sølu á heimasíðuni hjá Hotel Føroyum, men sum koma frá ella eru fyriskipað av triðja manni, kunnu ikki avlýsast uttan so, at nærri fráboðan er givin um hetta í lýsing um tiltakið, tænastruna ella vøruna.

Allar fráboðanir um avlýsingar skulu gevast skrivliga til Hotel Føroyar á teldupostadressu [hf@hotelforoyar.fo](mailto:hf@hotelforoyar.fo).

Gávukort skulu nýtast innan eitt ár eftir, at gávukortið er keypt. Gávukort kunnu ikki innloysast til reiðan pening, men bert til veitingar og tænastrur, sum vanligar verða veittar av Hotel Føroyum ella deildum tess.

Møguleiki fyri at avlýsa eina veiting:

Hotel Føroyar hevur fullan rætt til at avlýsa eina veiting, so sum eitt tiltak, hølisleigu, vistveiting ella tílíkt. Um Hotel Føroyar avlýsir eina veiting, verður goldna upphæddin fyri veitingina fult endurgoldin, tó ikki umsitingargjaldið og avgreiðslugjaldið. Endurgjaldið er ongantið størri enn tann upphædd, sum goldið er Hotel Føroyum fyri veitingina.

Tó, um Hotel Føroyar avlýsir eina veiting vegna orsøkir, sum Hotel Føroyar ikki kann ábyrgdast fyri, t.d. vegna force majeure, hevur Hotel Føroyar ikki skyldu at endurrinda gjaldið fyri avlýstu veitingina.

Hotel Føroyar hevur ikki ábyrgd fyri nakað tap ella nakran miss, sum bíleggjarin hevur í sambandi við veitingina ella um veitingin verður avlýst og heldur ikki, um feilur kemur fyri í bíleggingini ella í veitingini.

Omanfyrinevndu bíleggingartreytir eru galdandi fyri Hotel Føroyar og allar deildir tess.

## PAYMENT AND CANCELLATION AGREEMENT

### § 1 General

The Hotel Føroyar Payment and Cancellation Agreement states the contractual contents according to which Faroese accommodation providers generally conclude accommodation contracts with their guests.

The Hotel Føroyar Payment and Cancellation Agreement do not exclude special agreements.

According to the terms and conditions given, this contract becomes effective as soon as the room/rooms, locations, or other supplies and services have been ordered and confirmed. Time permitting, the hotel will acknowledge the guest's reservation and ask for reconfirmation. If deposits requested by the hotel are not paid by the given date, Hotel Føroyar is entitled to cancel the booking.

### § 2 Contract Partners

In cases of doubt the contract partner of the accommodation provider is the ordering party, even if he placed, or jointly placed, the order for other specifically named persons.

The persons availing themselves of the accommodation are guests in accordance with the contract conditions.

### § 3 Pre-Payment

By placing your booking you agree to the following payment terms:  
Hotel Føroyar can request an advance payment of the entire agreed payment amount following these terms:

<b>Booking fee:</b> 25% of total arrangement is to be paid 90 days prior to arrival
<b>Advance payment:</b> 75% of total arrangement is to be paid 30 days prior to arrival
Any rest payment has to be paid prior to departure
Participant list is to be sent 30 days prior to arrival

Lack of deposit payment will result in cancellation of an arrangement as stated in § 4 about cancellations.

In as far as advance payments have not already been made, all outstanding costs are due for payment in the hotel on the day of departure.

Please note that all hotel guests are registered upon check in. Hotel Føroyar also demands a credit card print from guests that are paying for extra services during their stay at the hotel.

## § 4 Cancellation

Cancellation of an arrangement can be done without any financial loss 90 days prior to arrival date. Cancellations less than 90 days prior to the start of the arrangement, Hotel Føroyar is obliged to reimburse you at the following terms:

<b>90-30 days:</b> booking fee is not refundable
<b>Less than 30 days:</b> Advance payment is not refundable

## § 5 Cancellations of individual bookings

Hotel room cancellations are accepted free of charge if notification is received by the hotel 24 hours prior to arrival. In case of a later cancellation, or arrival failure without prior cancellation (no show), the hotel is entitled to charge one night of the original reservation.

This is not valid during trade fairs or other larger events, taking place in Hotel Føroyars' region. In this case a cancellation is only free of charge if it is made no later than 90 days prior to begin of the event and follow the terms as stated in fig.4.1.

## § 6 Arrival and departure

Reservations are held until 2100 hrs on the date of arrival. Without prior notice stating otherwise, the hotel may then reallocate the rooms. This is not valid for reservations guaranteed by advance payments, vouchers or credit card transactions made through businesses recognized by the hotel.

## § 7 Various

Rates are subject to change in case of and due to inflation, tax or duty increases. The price can vary immediately and the client will be informed of these alterations. Any alterations of prices and arrangement details must be in writing by the hotel and accepted in writing by the client in order to be valid.

The hotel cannot be held liable for any lost or stolen items belonging to the client or the client's guests. It is solely the client's responsibility to inform his guests about the safety measures at Hotel Føroyar. A safe is at the reception for the guests to use.

The hotel's contractual partners, that is, the guest himself or his host bear comprehensive liability for damages caused by themselves or their guests.

Contracted, but not consumed services, are neither refunded nor does this reduce rates.

The correction of printing errors and obvious mistakes in calculation without any special notification is reserved.
